2 **ELECTRONIC RECORDINGS OFFERED IN EVIDENCE-TRANSCRIPTS**

3 The party seeking the admission of an audio or video tape  
4 into evidence is required to submit a typewritten transcription of  
5 it:

6 "Unless otherwise ordered by the trial judge, a party offering  
7 into evidence an electronic sound or sound-and-video recording  
8 shall tender to the court and to opposing parties a typewritten  
9 transcript of the electronic recording. The transcript shall be  
10 marked for identification and shall be a part of the clerk's  
11 transcript in the event of an appeal.

12 Unless otherwise ordered by the trial judge, the court reporter  
13 need not take down or transcribe an electronic recording that is  
14 admitted into evidence."
